Terms & Conditions



1. The promoter

- 1.1 The promoter is: Scottish Golf Limited (company number SC308709) of The Dukes, St. Andrews, Fife, Scotland KY16 8NX ("**Scottish Golf**").

2. The competitions

- 2.1 The title of these competitions is 'Win a Round from Home'.

3. How to enter

- 3.1 There will be six separate competitions (each a "**Competition**" and, together, the "**Competitions**"), each of which will run between the following times and dates:

- (a) Competition 1: will open from 9am on 5 August 2020 and will close on 18 August 2020 at 5pm ("**Competition 1**");
- (b) Competition 2: will open from 9am on 19 August 2020 and will close on 1 September 2020 at 5pm ("**Competition 2**");
- (c) Competition 3: will open from 9am on 2 September 2020 and will close on 15 September 2020 at 5pm ("**Competition 3**");
- (d) Competition 4: will open from 9am on 16 September 2020 and will close on 29 September 2020 at 5pm ("**Competition 4**");
- (e) Competition 5: will open from 9am on 30 September 2020 and will close on 13 October 2020 at 5pm ("**Competition 5**"); and
- (f) Competition 6: will open from 9am on 14 October 2020 and will close on 27 October 2020 at 5pm ("**Competition 6**").

- 3.2 The entries for each Competition must be received by Scottish Golf by no later than the relevant closing date and time specified in clause 3.1 (each a "**Closing Date**"). All competition entries received after the relevant Closing Date are automatically disqualified.

- 3.4 Scottish Golf will **not** accept:

- (a) responsibility for Competition entries that are lost, mislaid, or incomplete, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
- (b) proof of transmission as proof of receipt of entry to the relevant Competition.

3.5 By submitting a Competition entry, you warrant that you are over the age of 18 years old and you are agreeing to be bound by these terms and conditions together with any specific rules or conditions explained or notified by Scottish Golf as relevant to the Competitions (as displayed on <https://scottishgolf.org/> or otherwise).

4. Eligibility

4.1 The Competitions are strictly only open to residents in the UK aged 18 years or over, **except**:

- (a) employees of Scottish Golf or Anheuser-Busch InBev SA/NV or their respective holding or subsidiary companies;
- (b) employees of agents or suppliers of Scottish Golf or Anheuser-Busch InBev SA/NV or their respective holding or subsidiary companies, who are professionally connected with any Competition or its administration; or
- (c) members of the immediate families or households of individuals referred to in (a) or (b) above.

4.2 In entering a Competition, you confirm that you are eligible to do so and eligible to claim the relevant Prize (as defined and set out below). Scottish Golf may require each Prize-Winner (as defined below) to provide all such proof as it deems necessary to satisfy itself that the relevant Prize-Winner is eligible to enter the relevant Competition and receive the relevant Prize. The eligibility of any entrant is at the sole discretion of Scottish Golf. If ineligible, entrants will not be entitled to receive the relevant Prize, and the relevant Prize awarded may be revoked.

4.3 Scottish Golf will not accept Competition entries that are: (a) automatically generated by computer; (b) completed by third parties or in bulk; (c) illegible, have been altered, reconstructed, forged or tampered with; or (d) incomplete.

4.4 There is a limit of one entry to each Competition per person. Entries made on behalf of another person will not be accepted and joint submissions are not allowed.

5. The prize

5.1 The prize for each Competition is as follows (each a “**Prize**” and, together, the “**Prizes**”):

- (a) Competition 1: a case of 24 “Budweiser” bottles
- (b) Competition 2: a case of 12 “Bud Light” bottles
- (c) Competition 3: a case of 12 “Becks” bottles

- (d) Competition 4: a case of 10 “Corona” bottles
- (e) Competition 5: a case of 12 “Michelob Ultra” bottles
- (f) Competition 6: a case of 24 “Stella Artois” bottles

- 5.2 There is no cash alternative to any Prize. Scottish Golf reserves the right to substitute a Prize with a prize of equal or greater value.
- 5.3 The Prizes are supplied by Anheuser-Busch InBev SA/NV. The Prizes are not negotiable or transferable.

6. Winners

- 6.1 Subject to the terms of these terms & conditions and unless otherwise stated by Scottish Golf, a winning entrant for each Competition shall be selected by Scottish Golf at random (the “**Prize-Winner**”) from all entries that Scottish Golf (at its complete discretion) deems to qualify for entry into the relevant Competition. The decision of Scottish Golf is final and no correspondence or discussion will be entered into.
- 6.2 Scottish Golf will contact each Prize-Winner personally as soon as practicable after the Closing Date of the relevant Competition, using the telephone number or email address provided with the Competition entry. Scottish Golf will attempt to contact each Prize-Winner twice. In the event that the relevant Prize-Winner does not respond to Scottish Golf within 24 hours of the second e-mail or call, or is unable to accept the relevant Prize for any reason, or Scottish Golf determines (at its sole and absolute discretion) that the relevant Prize-Winner has breached these terms and conditions, Scottish Golf reserves the right to replace that Prize-Winner with another prize-winner. Only the Prize-Winner will be notified in each case.
- 6.3 Should any doubt arise as to an entrant’s eligibility (including the entrant’s age), Scottish Golf reserves the right to withhold the relevant Prize until such proof of eligibility and identity has been confirmed or, if such proof is not produced on request, to disqualify the entrant from the relevant Competition.
- 6.4 Scottish Golf will either publish or make available information that indicates that valid awards of the Prizes took place. To comply with this obligation, Scottish Golf will send the surname and county of the relevant Prize-Winner to anyone who writes to the address set out in clause 1 (enclosing a self-addressed envelope) within one month after the Closing Date of the relevant Competition. Scottish Golf reserves the right not to respond to such requests after this time.

7. Claiming the prize

- 7.1 Please allow 14 days for delivery of the relevant Prize from the date that Scottish Golf satisfies itself of the relevant Prize-Winner’s eligibility pursuant to clause 6.3.
- 7.2 A Prize may not be claimed by a third party on the Prize-Winner’s behalf.

- 7.3 Scottish Golf does not accept any responsibility if the Prize-Winner is not able to take up the relevant Prize.

8. Limitation of liability

- 8.1 Neither Scottish Golf nor Anheuser-Busch InBev SA/NV (or their respective agents and distributors) accept any liability (other than for death or personal injury caused by their negligence or other liabilities that cannot, as a matter of law, be excluded) for any damage, loss, costs, expenses or disappointment, whether direct or indirect, caused to or suffered by the organising or holding of the Competitions or as a result of any entrant's participation in the Competitions or as a result of the winning, collecting, use or enjoyment of any of the Prizes, or if any of the Competitions do not run as planned or if any of the Prizes are unable to be delivered for any reason. Scottish Golf will not be liable if any of the Prizes are unable to be offered.
- 8.2 If any Competition or any part thereof is not capable of running or being completed as planned for any reason, including but not limited to reasons of infection by computer virus, bugs, tampering, unauthorised intervention, technical failures or any other causes beyond the control of Scottish Golf, Scottish Golf reserves the right to cancel, terminate, modify or suspend that Competition without liability.

9. Data protection and publicity

- 9.1 Information (including personal information) submitted in an entry will, unless specifically stated otherwise, be used by Scottish Golf in accordance with Scottish Golf's privacy policy located on its website: <https://scottishgolf.org/> ("**Privacy Policy**"). All entrants agree that if they are a Prize-Winner, they will take part in any promotional activity reasonably requested by Scottish Golf. By entering a Competition, entrants agree to the use of their name, county, entry and any other details and/or materials submitted in connection with the relevant Competition (including, but not limited to, announcing the results of the relevant Competition) and any other promotional purpose as Scottish Golf may deem appropriate.
- 9.2 All individuals submitting entries hereby acknowledge that their personal data will be processed by Scottish Golf in accordance with the requirements of the General Data Protection Regulation 2016/679 and the Data Protection Act 2018, and in accordance with Scottish Golf's Privacy Policy.

10. General

- 10.1 If there is any reason to believe that there has been a breach of these terms and conditions, Scottish Golf may, at its sole discretion, reserve the right to exclude any entrant from participating in the Competitions.
- 10.2 Scottish Golf reserves the right to hold void, suspend, cancel, or amend the Prizes, the Competitions or these terms and conditions (as the case may be) where it becomes necessary (at its sole and absolute discretion) to do so. Any such changes will be posted on Scottish Golf's website.

- 10.3 If any provision of these terms and conditions is found to be invalid by any court having competent jurisdiction, the invalidity of that provision will not affect the validity of the remaining provisions of these terms and conditions, which shall remain in full force and effect.
- 10.4 These terms and conditions (and any non-contractual claims arising out of or in connection with them) shall be governed by Scots law, and the parties submit to the exclusive jurisdiction of the courts of Scotland to settle any dispute in connection with them.
