Privacy Notice (Children) – Scottish Golf Mobile App

WHO WE ARE

The Scottish Golf App will teach you new stuff about golf and help you learn some new skills, and if you have signed up to the OpenPlay part of the App, this can be used to help give you and keep a golf handicap.

Scottish Golf looks after golf in Scotland and helps people get involved in golf at all levels from playing at local golf clubs all the way up to the professional players like Paul Lawrie and Robert MacIntyre. You trust us with the information you give to us and we don't want to let you down. So read this policy carefully so you know what to expect.

If you are very young (under 13) you will need to get a Parent/Carer (maybe your mum or dad) to help you use our websites and get involved in some of the fun things we do that are meant for kids. If you are under 13, we will normally only send you newsletters and information about other stuff that you as a young golf fan might like if Your Parent/Carer has told us it is OK for us to send them.

INFORMATION ABOUT YOU

We need some information about you so that we can do the things we promise to do for you. We tell you all the detail when you or Your Parent/Carer signs you up for each new Scottish Golf thing but, to give you an idea, the types of information we will ask for are:

- your name: usually your first name and last name, as well as your username for the App;
- how we can contact you: such as your address or an email address (if you have one) and information about how we can get in touch with Your Parent/Carer (like your mum or dad) to make sure they are happy with what we will do with your information;
- how old you are: this will be important because some of the things we do and some of our competitions are only for young people so we need to check that you are the right age to take part;
- payment information: if you or Your Parent/Carer are paying for anything on our App (and you should not ever do this without getting Your Parent/Carer's permission first), then we will use those details to help you to use the App, and to book golf activities and enter competitions;
- whether you are a boy or girl: this helps us to make sure that everyone gets a fair chance to join in golf activities;
- where you are: this helps us to make the App work in the best way for you, including to help you to enter your scores when you play golf;
- information you give to us: such as any comments (good or bad) you give to us about activities you have taken part in, things you have read on our website or in messages we send you and anything else about golf or what we do; and
- what gadgets you use: such as the computer, smartphone or iPad you have our App on.

Most of this information will come from you or Your Parent/Carer, and some will come from your gadget that you use to go to our App. Sometimes we add some information that we already have or that we get from someone else who helps us keep our promises to you (like the people that set up our App) or that run golf events (like golf clubs).

COOKIES AND OTHER TECHNICAL STUFF

We know kids are really good with gadgets so you probably know we don't mean the type of cookies that you eat. But, just in case, cookies are tiny little things that get stored on gadgets (like your computer, smartphone or iPad) and tell us what you like on our website or in our App. These help us to make sure we tell you about things that you and other kids of your age group are interested in. At the moment, we

don't use cookies on our website or in our App, but if we start using them in the future we will let you know what their names are and what jobs each of them does.

WHAT WE WILL DO WITH YOUR INFORMATION

We will use personal information about you to:

- welcome you to Scottish Golf by creating an account especially for you;
- do what we promise by sending and doing the things we promise such as sending you newsletters you ask us for or telling you about competitions if you have told us you would like us to;
- get in touch if we can't do the things we promise or if we need more information to be able to do them;
- make sure you and others are safe at golf events and activities;
- understand what fans like so that we can create new things and improve what we offer;
- make sure everyone gets a fair chance to be involved in golf whether you are a boy or girl and wherever you may come from;
- get to know you so we can make things personal for you; and
- sort out any problems.

WHY WE ARE ALLOWED TO USE YOUR INFORMATION

We are allowed to use your information:

- to do what we promise we will do: if we promise that we will do something for you, then we will use your information to help us keep that promise (this is what adults call a 'contract');
- to get to know you and keep in touch with you: we will use your information to get to know you better and keep in touch with you, but only if Your Parent/Carer has agreed that we can do this (adults call this 'consenting');
- to make sure everyone gets a fair chance: we want to make sure that everyone gets a fair chance in golf and there are rules that mean we have to do the right thing so - it doesn't matter if you are a boy or girl, what you look like, or where your family comes from – everyone should have the same chances. We will make sure an adult has understood how we will use your information to give you fair chances to be involved and has said it is OK; and
- to promote golf and encourage people to get involved: we may use your information to get other people involved in golf so they can find out how great golf can be, but we will make sure that this doesn't harm you in any way.

WHO WE MAY SHARE YOUR INFORMATION WITH

There are a lot of people involved with making golf great for everyone. If you play golf at a local club, you will know a bit about your club and may play in competitions too. We also have work with other national golf bodies within the United Kingdom (they help the clubs do things right). We sometimes give them information about golf fans so that they can understand what you like and can do things to make golf more fun and interesting for you.

We have chosen some really cool companies to help us give you what you ask for (like companies that organise competitions or look after our website and our App). These companies are good at what they do for us and they have to follow our rules when they see your information, so you don't have to worry.

Sometimes we would like to tell you about other golf stuff, such as competitions and fun days out at golf events, what is happening with golf clubs teams and big events and also about people and companies that help make golf exciting by supporting us (these are our sponsors and partners). If you are under 13, we will only do this if Your Parent/Carer tells us that it is OK. When Your Parent/Carer tells us that we can send you information – we will let them choose how we send it to you and will make sure they can change their minds any time they want.

HOW LONG WE KEEP YOUR INFORMATION

We will normally keep your information just for as long as we need it – usually just for as long as you are using the App, or have an account with us.

If you delete the App and delete your account completely, we will usually delete all of your information soon after you do this.

If you delete the App or cancel your subscription to OpenPlay, but you don't delete your account completely, we will normally keep your information for another 2 years, so that you can restart using the App (and OpenPlay if you choose to) again if you want. We will usually delete your information the end of those 2 years, if you have not used the App or restarted your subscription to OpenPlay at all in that time.

WHERE WE KEEP YOUR INFORMATION

We usually keep your information in the United Kingdom or in the European Economic Area (if geography is not your thing and you want to know which countries are in the European Economic Area, click on this link: [show me the countries](#)).

If we need to hold your information anywhere else, we will tell you and we will make sure we follow the rules to protect it properly.

HOW WE KEEP YOUR INFORMATION SAFE

We think it is really important to keep your information safe and keep it a secret from people that are just nosy or don't care about keeping it private. We have lots of technology to make sure people can't see your information, use it or give it to anyone else unless we have given them permission.

WHAT YOU CAN ASK US TO DO WITH YOUR INFORMATION

You trust us with your information and you have a quite a few legal rights over it. These include:

- right to see your information: you can ask us to explain what information we have about you and what we do with it and can also ask for a copy of it;
- right to stop us sending you information: you can stop us from sending information about our activities, competitions and other things we think you may like at any time just by telling us to;
- right to stop consenting: if we have your OK to do something with your information, or Your Parent/Carer has told us it is OK, you or they can ask us to stop doing it by telling us that it is not OK any more;
- right to correct things: if any of the information we hold about you isn't correct, you can ask us to correct it (for example if you move house);
- right to limit what we do with your information: sometimes you may be able to limit what we do with your information.;
- right to delete your information: sometimes you may be able to make us get rid of your information;
- right to object: sometimes, you maybe allowed to object to us doing things with your information; and
- right to have things sent to someone else: if you give us personal information using a gadget, you may be able to make us pass that information on to another company.

IF YOU ARE NOT HAPPY

We will work very hard to make sure all the information we have about you is looked after but if you are very unhappy about what we do and we can't fix things you can also tell the Information Commissioner (the person who tells off companies in the United Kingdom if they do the wrong thing

with your information). Your Parent/Carer should be able to help you complain to the Information Commissioner if you feel you need to.
